- Tuition is paid in 3 installments and covers the entire school year (September - end of May)
- There is a 5% discount for siblings
- **Tuition is not refundable under any circumstances.**
- There is a 10 day grace period for late payments. A weekly \$30.00 recurring late fee will be charge for late payments received after the grace period has ended.
- Should a dancer's family fall under financial hardship, we require an open line of communication so a payment plan can be arranged to bring their account current.
- The undersigned agrees to pay the full amount listed above.
- The undersigned understands that the amount above is due regardless of any changes in the dancer's or family's circumstances.
- In the event we are forced into another quarantine, classes will maintain the same schedule and continue virtually, and partnering classes will be replaced with variations class.
- Monthly payment plans may be arranged at an additional 5% monthly processing fee.
